

**THE ‘WIN A TRIP TO HANG OUT BACKSTAGE WITH PAUL RUDD, DAVID KOECHNER,
JASON SUDEIKIS, ROB RIGGLE & ERIC STONESTREET’ GIVEAWAYS
TERMS & CONDITIONS**

1. The ‘Win a Trip to Hang Out Backstage With Paul Rudd, David Koechner, Jason Sudeikis, Rob Riggle & Eric Stonestreet’ Giveaways (“Giveaways”) are open only to individuals who are legal residents of the 50 United States or the District of Columbia, age 18 or older or, if older, the age of majority in their jurisdiction at the time of entry who agree to and comply with these Terms & Conditions (“Eligible Individuals”). 2. The Giveaways are sponsored by Children’s Mercy Hospital (“Sponsor”) and administered by GoFundMe, Inc., which operates a crowdfunding platform called CrowdRise (“CrowdRise”). By participating in the Giveaways, each Participant accepts the Terms and Conditions stated herein, agrees to be bound by the decisions of the Sponsor and CrowdRise and warrants that such Participant is eligible to participate in the Giveaways. To receive a Giveaway (“Prize”) in Section 3 below), you must comply with all facets of these Terms & Conditions and all decisions by Sponsor and CrowdRise.
3. The Giveaway Period: The Giveaways are available on a first come, first served basis and while supplies last, beginning on April 13, 2018 at 12:00pm Eastern Time (ET) and ending no later than May 11, 2018 at 11:59:59pm ET, such period referred to herein as the “Giveaway Period”. CrowdRise’s server and computer clock is the official time-keeping device for the Incentives.
4. How to Receive a Giveaway (“Prize”):

Go to the CrowdRise website located at: <https://www.crowdrise.com/bigslick2018> (the “Campaign”):
 - a. Every Eligible Individual to donate at least ten dollars (\$10) to the Campaign will receive one entry in the VIP sweepstakes and a Digital Thank You. Restrictions apply.
 - b. Every Eligible Individual to donate at least fifty dollars (\$50) to the Campaign will receive five entries in the VIP sweepstakes and a Digital Thank You. Restrictions apply.
 - c. Every Eligible Individual to donate at least one hundred dollars (\$100) to the Campaign will receive ten entries in the VIP sweepstakes, a Big Slick bottle opener and a Big Slick koozie. Restrictions apply.
 - d. Every Eligible Individual to donate at least two hundred and fifty dollars (\$250) to the Campaign will receive 25 entries in the VIP sweepstakes, a Big Slick poster and a Big Slick water bottle. Restrictions apply.
 - e. Every Eligible Individual to donate at least five hundred dollars (\$500) to the Campaign will receive 50 entries in the VIP sweepstakes, an autographed Big Slick poster and a Big Slick water bottle. Restrictions apply.

Limit one (1) Prize per entrant. So, if you give at least \$500 in eligible monetary donations and receive Prize E, you will not receive Prizes A, B, C or D.

The Approximate Retail Value (“ARV”) of each prize: Big Slick bottle opener (Five dollars, \$5); Big Slick koozie (Ten dollars, \$10); Big Slick poster (Fifteen dollars, \$15); Big Slick water bottle (Twenty dollars, \$20); Big Slick autographed poster (Twenty dollars, \$20). The actual retail value may be different than the approximate retail value or from that pictured in advertising and the winner will not be compensated for the difference.

ENTER PRIZE LIMITATIONS / RESTRICTIONS.

The prizes are non-transferable by the recipients and no cash equivalent or substitution is offered, except at the sole discretion of Sponsor. All prize details not specified in these Official Rules will be determined in Sponsor’s sole and absolute discretion. In order to receive a prize, you may be required to provide proof of identification or eligibility. You will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the prize you receive. 5. To receive a prize, you must donate on the Website via the Campaign page using a credit card through CrowdRise and its third-party payment processor during the Giveaway Period. Payments made outside of the Campaign, outside the Giveaway Period and/or offline, even if recorded on the Website, including, but not limited to, donations by cash, credit card, money order, donations made to an entrant’s fundraising page on CrowdRise.com that are not part of the Giveaways, or any other payment not successfully processed online via credit card are not eligible and will not be counted toward the Incentives. **Donations can take time to process.** All donations must be successfully processed to completion through CrowdRise and its third-party payment processor(s) **before** the end of the Giveaway Period in order to count toward the total amounts raised for the applicable Campaign. CrowdRise has the right to verify any such donation, and any such donation that is subject to chargeback or dispute may not count toward the total amount raised. Donations are non-refundable. Neither Sponsor nor CrowdRise is responsible for any delays in processing any donations.

Donations received in the Promotion go to Children’s Mercy Hospital, EIN 44-0605373, a non-profit organization qualified under Section 501(c)(3) of the U.S. Internal Revenue Code of 1986, as amended (the “Beneficiary”). The Beneficiary of your donation may receive less than the full amount that you donate after the deduction of administrative and processing fees in accordance with the CrowdRise Terms and Conditions.
