

## **THE HARRY POTTER AND THE CURSED CHILD INCENTIVES TERMS & CONDITIONS**

1. The 'Harry Potter and the Cursed Child' Incentives ("Incentives") are open only to individuals who are legal residents of the 50 United States or the District of Columbia and Puerto Rico or Canada (excluding Quebec) and any other country where permitted by law without restriction; the Incentives are not available to residents of Belgium, Cuba, Czech Republic, Finland, Iran, Iraq, Italy, Malta, North Korea, Norway, Quebec, Singapore, Sudan, Syria, Thailand; any additional countries on the United States list of embargoed countries, and all other countries where prohibited or restricted by law (the "Eligibility Area"). Entrants must be age 18 or older or, if older, the age of majority in their jurisdiction at the time of entry who agree to comply with these Terms & Conditions ("Eligible Individuals"). Shipping date shall be within six (6) months after the Incentives have ended, and the exact date is to be determined by Sponsor. In the event that Sponsor is unable to provide you with your Award(s) or any portion thereof, the Sponsor may elect, at its sole discretion, to provide such winner with the approximate value of such item in cash or award an alternate award of comparable or greater value, as determined by Sponsor in its sole discretion.
