

THE FANTASTIC BEASTS: THE CRIMES OF GRINDELWALD INCENTIVES PROMOTION TERMS & CONDITIONS

1. The ‘Fantastic Beasts: The Crimes of Grindelwald Paris Premiere’ Incentives Promotion (the “Promotion”) is open only to individuals who are legal residents of the 50 United States or the District of Columbia and Puerto Rico or Canada (excluding Quebec) and any other country where permitted by law without restriction; the Sweepstakes is not open to residents of Belgium, Cuba, Czech Republic, Finland, Iran, Iraq, Italy, Malta, North Korea, Norway, Quebec, Singapore, Sudan, Syria, Thailand; any additional countries on the United States list of embargoed countries, and all other countries where prohibited or restricted by law (the “Eligibility Area”). To enter, you must also be at least age 18 or the age of majority in your jurisdiction, whichever is greater. Do not enter the Promotion if your country of residence, age or any other rule or law prohibits or restricts you from entering or participating in the Promotion, or prohibits, restricts or limits the award of the prize. You must be able to accept the award of the prize without rules or restrictions imposed by the jurisdiction in which you live. 2. The Promotion is sponsored by Lumos Foundation USA (“Sponsor”) and administered by GoFundMe, Inc., which operates a crowdfunding platform called CrowdRise (“CrowdRise”). By participating in the Promotion, each Participant accepts the Terms and Conditions stated herein, agrees to be bound by the decisions of the Sponsor and CrowdRise and warrants that such Participant is eligible to participate in the Promotion. To receive an Award (defined in Section 3 below), you must comply with all facets of these Terms & Conditions and all decisions by Sponsor and CrowdRise.
3. The Promotion Period: The Promotion is available on a first come, first served basis and while supplies last, beginning on June 8, 2018 at 11:00am Eastern Time (ET) and ending no later than July 6, 2018 at 11:59:59pm ET, such period referred to herein as the “Promotion Period”. CrowdRise’s server and computer clock is the official time-keeping device for the Promotion.
4. How to Receive a Promotion Award (“Award”):

- a. Every Eligible Individual to donate at least fifty dollars (\$50) to the Campaign will receive a MinaLima limited edition gold-foiled Fantastic Beasts print. Restrictions apply.
- b. Every Eligible Individual to donate at least seventy five dollars (\$75) to the Campaign will receive a limited edition Fantastic Beasts tee shirt. Restrictions apply.
- c. Every Eligible Individual to donate at least one hundred and twenty dollars (\$120) to the Campaign will receive both a MinaLima limited edition gold-foiled Fantastic Beasts print and a limited edition Fantastic Beasts tee shirt. Restrictions apply.

- d. The first ten (10) Eligible Individuals to donate at least two thousand five hundred dollars (\$2,500) to the Campaign will receive a signed screenplay book of Fantastic Beasts and Where to Find Them by J.K. Rowling. Restrictions apply.

Limit one (1) Award per entrant. So, if you give at least \$2,500 in eligible monetary donations and receive the signed screenplay, you will not receive a print or tee shirt.

The awards are non-transferable by the recipients and no cash equivalent or substitution is offered, except at the sole discretion of Sponsor. Shipping will only be to your physical mailing address (no P.O. Boxes) used at the time of payment, which must be in the Eligibility Area, except in Prize Provider's sole and absolute discretion. Neither Sponsor nor CrowdRise are or shall be responsible or liable for late, lost, misdirected or unsuccessful efforts to notify the Potential Winner(s) or for the prize utility, quality, or damages of any kind during shipping or anytime thereafter. Shipping date shall be within six (6) months after the Incentives have ended, and the exact date is to be determined by Sponsor. In the event that Sponsor is unable to provide you with your award(s) or any portion thereof, the Sponsor may elect, at its sole discretion, to provide such winner with the approximate value of such item in cash or award an alternate award of comparable or greater value, as determined by Sponsor in its sole discretion. No cash equivalent or other substitution of prize is offered.

5. Awards are offered on a first-come, first served basis and are available while supplies last.

To receive an award, you must donate on the Website via the Campaign page using a credit card through CrowdRise and its third-party payment processor during the Promotion Period to count toward the Promotion. Payments made outside of the Campaign, outside the Promotion Period and/or offline, even if recorded on the Website, including, but not limited to, donations by cash, credit card, money order, donations made to an entrant's fundraising page on [CrowdRise.com](https://www.crowdrise.com) that are not part of the Promotion, or any other payment not successfully processed online via credit card are not eligible and will not be counted toward the Promotion. **Donations can take time to process.** All payments must be successfully processed to completion through CrowdRise and its third-party payment processor(s) **before** the end of the Promotion Period in order to count toward the total amounts raised for the applicable Campaign. CrowdRise has the right to verify any such payment, and any such payment that is subject to chargeback or dispute may not count toward the total amount raised. Neither Sponsor nor CrowdRise is responsible for any delays in processing any payments. Results of the Incentives are not official until Sponsor and/or CrowdRise, or their respective duly authorized representatives, verify the recipients(s) of the Awards.
7. Donations received in the Promotion go to Lumos Foundation USA, EIN 47-2301085, a non-profit organization qualified under Section 501(c)(3) of the U.S. Internal Revenue Code of 1986, as amended (the "Beneficiary"). The Beneficiary of your donation may receive less than the full amount that you donate after the deduction of administrative and processing fees in accordance with the CrowdRise Terms and Conditions.
8. Awards may be taxable. Every entrant agrees that information provided by Sponsor or CrowdRise is not advice, including but not limited to, tax advice or legal advice, and every participant is advised to consult a professional, including a tax professional.
9. Shipping of Awards is limited to the Eligibility Area. Allow at least six (6) months for delivery.
