Requirements and Limits:

Potential winner is not declared final and shall not receive a Prize until winner (and guest) is verified by Administrator per Section 6 below. The Approximate Retail Value ("ARV") is one thousand five hundred dollars (\$1,500) per prize. Restrictions and Limitations:

Winner and guest must both be at least twenty-one (21) years of age.
